NATO and European Summit in Brussels

1 Introduction

On request of the Crisis Centre, airspace restrictions and surveillance will be established (Joint Umbrella) to guarantee the safety and security of the NATO and European Summit in Brussels.

These events will take place between 13 JUN and 15 JUN 2021.

This will impact the VFR flights within the areas mentioned below, but also the aerodromes located inside the Temporary Prohibited Zone.

Precise timing of zone activation will be published by NOTAM.

2 Zones

Those flights shall contact the appropriate ATS unit before entering.</p> <p>(2) Companies flying on State flight status shall contact Control and Reporting Centre Beauvechain 30 MIN before departure on +32 (0) 2 443 86 51 (or 650 or 653) and the crisis cell on +32 (0) 506 47 11 and add STS/STATE in their flight plan. Those flights shall contact the appropriate ATS unit before entering.</p> <p>(3) Activated by NOTAM.</p>

<p>(1) VFR flights intending to enter this TRA shall submit a flight plan to Brussels ARO (EBBRZPX) at least 60 MIN before departure. This flight plan shall additionally be sent to Steenokkerzeel ATCC via AFTN (EDDYBAFA and EBMIZGZF).</p> <p>(2) All flights shall be transponder mode A/C (designated SSR code given by Air Navigation Service Provider), mode S optional use.</p> <p>(3) All flights in airspace class G shall establish and maintain 2-way radio communication with BELGA Information on FREQ 129.325 MHZ. Flights must follow ATC instructions received from BELGA Information.</p> <p>(4) CIV aerobatic flights, CIV RPAS, crop dusters, gliders, ULM, motorized deltaplanes, paramotors, banner towing, CIV paradrops and manned free balloons prohibited.</p> <p>(5) Activated by NOTAM.</p>			

3 Airfields

CIV airfields (except EBBR) inside the TSA Temporary Prohibited Zone Brussels will also need to close during the activation of the zone. One NOTAM per airfield to be closed will be published in time.
